TOURNAMENT STANDING RULES:

1 Member must be a 500 Club member

1. Members of the Monterey 500' Club and members of the Monterey USBC holding a current card or Multi Member are eligible to participate, eg: woman/man, woman/woman.
2. The Tournament shall be bowled in one division, and the high series including handicap shall be declared the winner. In case of ties, prize money is combined and then equally divided unless tie is for last place, in which duplicate awards will be made. If tie is for first place, duplicate awards will be given.
3. USBC Rule #319 a-2, 319 d, and 319 e will not apply, 319 a-3 will apply.
4. Entering average will be the current Monterey Book Average. If no book average, use the highest current average of 21 games or more as of tournament closing date. Bowlers with none of these averages will bowl scratch. Current averages must be verified by League Secretary.
5. The Tournament will be a 3 game event on one pair of lanes.
6. A bowler arriving late must start their game in the frame which is then being bowled and shall receive >0' score for frames missed. The bowler will not be able to make up frames.
7. Any bowler who does not finish their scheduled game or games will be given credit for scores bowled only.
8. A dispute of any nature, except scoring, shall be immediately referred to the Tournament Officials, Local Association or to the USBC before prize payments are made. The grounds of appeal or protests shall be clearly and briefly stated. A dispute in scoring shall be made to the Tournament Officials within 24 hours.
9. If equipment failure on the assigned lanes should delay the normal progress of the series, the Tournament Officials may authorize the completion of game or series on another pair of lanes. Interrupted game and series must be resumed from the point of interruption. Any scores lost from scoring failure shall be rebowled.
10. Entry fee must accompany all entries (Check or Money Order) payable to: **Monterey "500" Club. Entry fee will not be refunded after closing date.**

THERE WILL BE A \$10.00 SERVICE CHARGE FOR ALL RETURNED CHECKS

11. Bowlers participating in Tournament may not practice on lanes scheduled for play within one hour before squad time.
